CASUAL BERTHING POLICY

1 RPYC MEMBERS

- 1.1 The Fremantle Annexe is an integral part of the Royal Perth Yacht Club and short term berthing free of charge can be arranged subject to notice and space availability for Full Members with vessels ordinarily kept at Crawley.
- 1.2 Any period over and above the short term stay basis will be strictly by arrangement with the Annexe Harbourmaster or Marina and Membership Manager and dependent upon Harbour operational requirements.
- 1.3 RPYC Member (non-pen holder) - a pen charge may be applied to a maximum of 30 days in any 12 months.
- 1.4 RPYC Member (Crawley pen holder) – no pen charge will apply for up to 30 days (excludes vessels not penned at Crawley). After 30 days, a pen charge equivalent to the Fremantle Pen rate will apply.

2 NON RPYC MEMBERS

- 2.1 This includes those with Reciprocal Membership of RPYC through their “mother” Club.
- 2.2 At the discretion of the Annexe Harbourmaster, vessels (including racing yachts) belonging to owners of other yacht clubs (*including RPYC reciprocal memberships*) may be provided with short term berthing subject to;
 - 2.2.1 Space Availability
 - 2.2.2 Provide proof that the vessel is insured, including a minimum \$10 million public liability.
 - 2.2.3 The Vessel is in a seaworthy condition.
 - 2.2.4 Acknowledgement of RPYC current By-Laws (*supplied by RPYC*).
 - 2.2.5 No visiting vessel shall be entitled to berth more than 30 days in any calendar year.
 - 2.2.6 The Owner to provide contact details including address and telephone contact.

2.2.7 A Calendar year will commence 1st September annually.

3 SCALE OF CHARGES

3.1 RPYC Members (*excluding Reciprocal*)

3.1.1 Crawley pen holders – no pen charge up to 30 days. After 30 days, pen fee equivalent to the Fremantle Pen rate will apply.

3.1.2 Non-pen holders – as per below table. A maximum period in any calendar year will be 30 days.

3.3 Rate Conditions

3.3.1 Maximum period in any calendar year will be 30 days.

3.3.2 Peak Period – 18th December through to 31st January, Easter Weekend (Good Friday to Easter Monday incl.), gazetted WA Long Weekends, Rottnest Channel Swim and Port to Pub Swim.

3.3.3 Peak Rates are applicable during the peak periods.

4 ACCESS and PARKING

4.1 A temporary Visitor Access Card will be issued giving access to the Annexe, including Clubhouse amenities and Car Park.

4.2 Car parking is restricted to one vehicle only in area designated by Annexe Harbourmaster.

4.3 In reference to racing yachts, **No Parking of Vehicles by Crew** is permitted.
