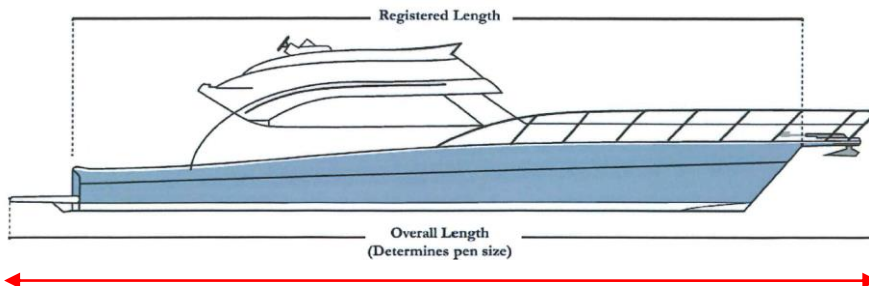
**PEN / HARDSTAND ALLOCATION & OCCUPANCY POLICY

**PEN / HARDSTAND ALLOCATION**

1. Pen Waiting Lists are maintained by the Marina and Membership Manager in order of application date, showing boat name, LOA, Power/Sail, owners name and size of pen required. Separate lists are maintained for Crawley Pens, Fremantle Pens and for Hardstanding Bays.
2. Sailing boats take priority over power boats.
3. Pens may be allocated to Members as defined in Club By-Law 4.1.1. All owners or part owners must be members of the Club.
4. Pens are allocated on the basis of the "right size, right boat for pen basis" taking into account the LOA, Beam and Draft of boats on the waiting list.
5. Pens are allocated to Members by the Marina and Membership Manager in consultation with the General Manager.
6. Upon allocation of a Pen or Hardstand Bay, the member/s shall pay a Pen/Hardstand Allocation Fee of 1.3 times the current annual pen/hardstand rental amount. This amount is non-refundable upon relinquishing the pen/hardstand.

**PEN / HARDSTAND OCCUPANCY CONDITIONS**

1. Occupancy conditions are defined in Club By-Law, Section 4, Marinas and Hardstand Areas.
2. No boat may occupy a pen until it has been registered with the Club.
3. No boat may occupy a pen or hardstand bay until the owner has provided the Club with Proof of Ownership (DOT registration), a valid Certificate of Third Party Insurance with Third Party Cover of not less than \$10m.
4. Overall vessel length includes all fixtures extending beyond the bow and stern of the vessel.



5. Pens are not transferable on sale of vessel.
